The need for increased ventilation while maintaining a comfortable temperature should be balanced.</li></ul> <p>On dedicated transport:</p> <ul style="list-style-type: none"><li>• It is recommended that children and young people aged 11 and over continue to wear a face covering when travelling to school.</li><li>• It is no longer recommended maximising distance and minimising mixing, but unnecessary risks such as overcrowding should be minimised.</li><li>• Children, young people and adults should follow <u>public health advice</u> on when to self-isolate and what to do.</li><li>• They should not board dedicated transport or public transport if they have symptoms or other reasons requiring them to stay at home due to the risk of them passing on COVID-19.</li><li>• If a child or young person develops COVID-19 symptoms, however mild, while at school, they will be sent home.</li><li>• They should avoid using public transport and, wherever possible, be collected by a member of their family or household.</li><li>• In exceptional circumstances, if parents or carers cannot arrange to have their child collected, and it is age-appropriate and safe to do so, the child should walk, cycle or scoot home. Ill Health	Staff Pupils Others	Coronavirus Symptoms	<ul style="list-style-type: none"> <li>• Staff are informed of the symptoms of possible coronavirus infection, e.g. a cough, loss or change to sense of smell or taste and high temperature and are kept up-to-date with national guidance about the signs, symptoms and transmission of coronavirus.</li> <li>• Any pupil or member of staff who displays signs of being unwell, such as having a cough, fever or a loss or change to their sense of smell or taste, and believes they have been exposed to coronavirus, is immediately taken out of the class and placed in an area where they will not come into contact with others and are supervised at all times.</li> <li>• For pupils the relevant member of staff calls for emergency assistance immediately if pupils' symptoms worsen.</li> <li>• The parents of unwell pupils are informed as soon as possible of the situation by a relevant member of staff.</li> <li>• Where contact with a pupil's parents cannot be made, appropriate procedures are followed in</li> </ul>	MED		✓

			<p>accordance with those outlined in governmental guidance.</p> <ul style="list-style-type: none"> <li>• Unwell pupils who are waiting to go home are kept in an area where they can be at least two metres away from others.</li> <li>• Areas used by unwell staff and pupils who need to go home are appropriately cleaned once vacated, using a disinfectant and care to be taken when cleaning all hard surfaces.</li> <li>• If unwell pupils and staff are waiting to go home, they are instructed to use different toilets to the rest of the school to minimise the spread of infection.</li> <li>• Any pupils who display signs of infection are taken home immediately, or as soon as practicable, by their parents – the parents are advised to contact NHS 111 immediately or call 999 if the pupil becomes seriously ill or their life is at risk.</li> <li>• Any members of staff who display signs of infection are sent home immediately and are advised to contact NHS 111 immediately or call 999 if they become seriously ill or their life is at risk.</li> <li>• Any medication given to ease the unwell individual's symptoms, e.g. Paracetamol, is administered in accordance with the Administering Medications Policy.</li> </ul>

Positive Cases	Pupils Staff	Infection control	<ul style="list-style-type: none"> <li>School no longer need to do contact tracing as close contacts will be identified via NHS Test and Trace.</li> <li>School will support NHS Test and Trace when required to help identify close contacts</li> </ul> <p><b>From 16<sup>th</sup> August 2021</b></p> <ul style="list-style-type: none"> <li>From 16 August 2021, children <b>under the age of 18 years old will no longer be required</b> to self-isolate if they are contacted by NHS Test and Trace as a close contact of a positive COVID-19 case.</li> <li>Instead, children will be contacted by NHS Test and Trace, informed they have been in close contact with a positive case and advised to take a PCR test.</li> <li>We would encourage all individuals to take a PCR test if advised to do so.</li> </ul> <p><b>Over 18 years of age</b></p> <ul style="list-style-type: none"> <li>18-year-olds will be treated in the same way as children <b>until 6 months after their 18th birthday (updated 06.09.2021)</b>, to allow them the opportunity to get fully vaccinated. At which point, they will be subject to the same rules as adults and so if they choose not to get vaccinated, they will need to self-isolate if identified as a close contact.</li> </ul>	MED		✓

			<ul style="list-style-type: none"> <li>Continue to have a role in working with health protection teams in the case of a local outbreak. If there is an outbreak in a setting or if central government offers the area an enhanced response package, a director of public health might advise a setting to temporarily reintroduce some control measures.</li> </ul> <p><b>Staff / Pupils</b></p> <ul style="list-style-type: none"> <li>with a positive lateral flow test result should self-isolate in line with the stay at home guidance and get a PCR test to check if they have COVID-19 and continue to self-isolate</li> <li>If the PCR test is taken within 2 days of the positive lateral flow test, and is negative, it overrides the self test and the pupils/staff can return to school as long as the individual doesn't have COVID-19 symptoms</li> </ul>

- Staff are vigilant and report concerns about their own, a colleague's or a pupil's symptoms to the Headteacher or SLT as soon as possible. .
- The school is consistent in its approach to the management of suspected and confirmed cases of coronavirus.
- The school is informed by pupils' parents when pupils return to school after having coronavirus – the school informs the relevant staff.
- Staff inform the headteacher when they plan to return to work after having coronavirus.
- A nominated person monitors the cleaning standards of school cleaning contractors and discusses any additional measures required with regards to managing the spread of coronavirus.

**The thresholds, detailed below, can be used by settings as an indication for when to seek public health advice if they are concerned.**

For most education and childcare settings, whichever of these thresholds is reached first:

- 5 children, pupils, students or staff, who are likely to have mixed closely, test positive for COVID-19 within a 10-day period: or
- 10% of children, pupils, students or staff who are likely to have mixed closely test positive for COVID-19 within a 10-day period
- All settings should seek public health advice if a pupil, student, child or staff member is admitted to hospital with COVID-19 by phoning the DfE helpline

Admitting children into school	Pupils Staff	Infection Control	<ul style="list-style-type: none"> <li>In most cases, parents and carers will agree that a pupil with symptoms should not attend the school, given the potential risk to others. If a parent or carer insists on a pupil attending your school, you can take the decision to refuse the pupil if, in your reasonable judgement, it is necessary to protect other pupils and staff from possible infection with COVID-19.</li> <li>Your decision would need to be carefully considered in light of all the circumstances and current public health advice.</li> </ul>	MED		✓

CEV children	Pupils Staff	Infection control	<ul style="list-style-type: none"> <li>• The UK Clinical Review Panel has recommended that no children and young people under the age of 18 should be considered CEV and under-18s should be removed from the shielded patient list.</li> <li>• Children and young people previously considered CEV should attend school and should follow the same COVID 19 guidance as the rest of the population. They may wish to take extra precautions however.</li> <li>• If a child or young person has been advised to reduce their social contact by their specialist, due to the nature of their medical condition or treatment, rather than because of the pandemic, they should continue to follow the advice of the specialist (updated 30/09/2021).</li> </ul>	MED		✓
Admitting people into school	Pupils Staff	Infection control	<ul style="list-style-type: none"> <li>• Pupils, staff and other adults <b>should not</b> come into school if they have symptoms, have had a positive test result or have been instructed to quarantine</li> <li>• Anyone staff or pupils within the school who appear to have COVID-19 symptoms are sent home, advised to avoid using public transport and, wherever possible, be collected by a member of their family or household and to follow public health advice</li> <li>• In the case of a pupil awaiting collection, they should be taken to a room away from other pupils and supervised</li> <li>• If the member of staff is in close contact with the child then they should wear appropriate PPE</li> <li>• A window should be opened for fresh air ventilation if possible</li> <li>• Any rooms that have been used for this purpose should be cleaned after they have left</li> </ul>	MED		✓
